The Orange County Children's Partnership (OCCP) Committee approved the following recommendations:

- i) Include equity ratio elements to allow continued reporting on indicators that lack data for update due to COVID-19 reporting disruptions. Benefits: identify racial disparities and promote/track equity in child health and well-being.
- ii) Revise behavioral health indicator to include behavioral health need, health care access and child and youth outcomes. Benefits: better understanding of children's behavioral health needs specific resources/services that best support our youth.

b) Legislative Updates – Kristina Traw/Debra Baetz

Legislature is in recess and there are no additional updates. The California budget was enacted in late June and the trailer bills were not enacted until mid-July. The bills are currently being reviewed to determine impacts. The CalFresh Program, federally known as the Supplemental Nutrition Assistance Program (SNAP) was increased by USDA-Food and Nutrition Service.

The California Department of Social Services (CDSS) will begin providing agencies with direction on how to implement the Families First Prevention Services Act. This bill will allow the state to draw federal funds to support child welfare.

Debra recommended a Families First legislation overview at next meeting.
