The May Revise is proposing to change the sharing ratio between the State/County for non-federal eligible cases in CWS, is proposing to eliminate CalWORKs, and reduce IHSS. Greg Buchert stated for CalOptima, it proposes to increase co-pays and the Feds need to agree if there will be a co-pay for children. Rick Martin stated that due to reductions in education there are 11 school districts in Orange County that have qualified budgets. This means that they do not have the funds to balance their budget for the next 2 years. Patty Rogers said there is a \$30 million cut to HCA. It also proposes AB3632 children going back to the responsibility of school districts. Janis White said Regional Center will have a 1.25% cut in addition to the 3% discount.

### 7. Program / Project updates

- Child Abuse Services Team Jyothi Atluri stated last month CAST saw a spike in their numbers. They're seeing an increase in the number of juvenile perpetrators. She reported that as of September 20, 2010 CAST will be housed at Orangewood. She invited everyone to see the new facility and there was a discussion regarding having next months OCCP meeting at Orangewood so everyone could tour CAST.
- Foster Youth Services Program Betsy DeGarmoe provided a handout highlighting foster youth services for 2009/2010. It included a graduation report, GPAs, CAHSEE, CST, information on youth attending college, AVID, trainings, and honors and achievements.

- Mental Health Services Act (Prop. 63) Jim Harte stated that their Centralized Assessment Team is operational. He reported the Board approved their Wraparound program and they are in week two of implementation. They are in the RFP process for Transitional Youth Services and have the Proponents Conference on Monday.
- Wraparound Hellen Howe stated that Wraparound completed their RFP process and has their new providers on board. There are still seven providers, but there have been reductions due to the budget so less families will be served. For FY 2009/2010 they served an average of 527 per month. There were 516 new referrals last year and the average length of service delivery is 12 months. Of the children that concluded services, 90% were in a home like environment. This is up from 81% in 2001. Wraparound is utilizing Educational Liaisons from OCDE.

### 8. Subcommittee Reports

- Transitional Planning Services Bob Malmberg stated they concluded the first 24-month cycle on THP+. They graduated their first group of youth and there were positive outcomes in regards to education. He stated AB12 will have a major impact, as it allows foster youth to electively stay in foster care until their 21<sup>st</sup> birthday.
- Child Welfare Services Redesign Planning Council Raquel Amezcua stated the Redesign Planning Council is looking at contracted services and case plans. She provided a handout with findings and recommendations from a recent survey. A workgroup came up with the recommendations and these will be brought back to the Council for action.
- Perinatal Substance Abuse Debbie Chitty stated that the Subcommittee completed the Perinatal Substance Abuse Study in 2007, compiled the report on their findings, conducted community presentations, and have published the results on websites. She asked the committee if there was a need to continue the Perinatal Substance Abuse Subcommittee. There will be a discussion at next months meeting.
- 9. **General Committee Member Comments:** Bill Steiner pointed out that this is the longest CA has gone without a State budget and many agencies/service providers are experiencing cash flow issues. - 1. **Introductions / Announcements:** Mike Ryan introduced David Wesson, the new OCCP FFA representative. He is replacing Clete Menke.
- 2. **Legislation/ budget update:** There was a discussion regarding proposed budget reductions and the anticipated impact on the various departments/agencies.
- 3. **ACTION ITEM**: Review and approve minutes from the October 21, 2010 meeting. Minutes approved.
- 4. 16<sup>th</sup> Annual Report on the Conditions of Children: Mary Ann Soden distributed copies of the Quick Guides. She also passed around a distribution list to ensure all agencies/organizations have received their reports. There was a discussion regarding the keynote speaker for the 17<sup>th</sup> Annual Report Community Forum. It was decided that we would request Hon. Yvette Verasteugi.

Rick Martin stated that it is going to be a challenge obtaining educational data by August 2011.

Alyce Mastrianni stated that Michelle Berelowitz provided a presentation on the Conditions of Children Report data for the Children and Families Commission. The Commissioners expressed concern on the lack of timely and specific data in some areas. Gallop is currently seeking partners to expand their real-time survey of well-being to include local communities such as an Orange County Index. Commission staff along with members of the Health Funders Partnership and the Orange County Forum will pursue additional information about this possible partnership to obtain more timely data. Also, an area of concern for the Commission is the data on low birth weight babies. To address this condition of children, the Commission along with UCI, CHOC and other partners develop a grant related to health science research and included addressing this data issue as part of the project. Project funding has been awarded which will allow the community to work on this area of concern this coming year. Mike requested she keep the OCCP updated on the project. Mike Ryan stated that the Board of Supervisors presentation and Community Forum went well. However, there was an error found in the Gang Membership data. It is very important for all agencies/departments to check their data for the last ten years to ensure accuracy. There was a discussion and it was decided that Mary Ann would send the data out for each agency/department to review by the end of February 2011.

5. **High School Completion Committee:** Rick Martin stated his subcommittee met with the Business Council. Rick is going to ask one of the Council members to attend either the February or March 2011 OCCP meeting. Rick provided the handout, *The High School Promise*. He is meeting with the Superintendent to see if he wants to endorse it and will keep the OCCP updated.

#### 6. Program/Project Updates:

- Child Abuse Services Team Ray Gallagher stated in 2010 there were 539 forensic interviews, 115 medical exams, 89 sexual abuse exams, 447 referrals from Victim Witness, and 1578 children served. There is no update on the Medical Director position.
- Foster Youth Services Program Betsy DeGarmoe stated the College and Career Fair held in October 2010 had 122 youth and 30 caregivers attend. The next one will be on October 8, 2011 in Fullerton. At the upcoming State Summit they are anticipating over 500 attendees and Judge Hernandez is going to lead a workgroup. Betsy stated she has been appointed co-chair of the State Task Force. She is also pursuing several RFA and grant funding opportunities.
- Mental Health Services Act (Prop 63) Ken Grebel stated the panel judging the proposals for the Children's and TAY Full Service Partnership has completed its evaluation of the proposals. The panel's recommendations for winning bidder(s) will be submitted to the Board for approval next month.
- Wraparound Hellen Howe stated Wraparound is celebrating ten years in Orange County. They have a new contract cycle this year with changes in providers. They are serving an average of 527 children per month, receive an average of 40 new referrals each month, since inception have received over 3000 referrals, and have an overall success rate of 80%. Mike Ryan requested that next time we have program updates, Hellen bring a document highlighting Wraparound outcomes.

#### 7. Subcommittee Reports:

Transitional Planning Services – Bob Malmberg stated there have been reductions to THP+. CFS will be able to keep all youth in placement through this year. However, next year, there will likely be a reduction to Scattered Site Apartments for youth. Bob stated that there are seven domains that are looked at to determine THP outcomes and Orange County is doing very well; youth are progressing in all areas.

- Child Welfare Services Redesign Planning Council Raquel Amezcua stated that CFS is in its second year of their System Improvement Plan (SIP) and continues to see positive outcomes. There continues to be an emphasis on recruiting parent mentors, who are also now involved with Team Decision Making (TDM) meetings. In addition, CFS continues to recognize the importance of celebrating families that successfully reunify and is working with community partners to hold Celebrating Family events to honor families and the people who have helped them.
- 8. **General Committee Member Comments:** Steve Livingston is the new chair for the Juvenile Justice Commission (JJC). Arlene Burt is retiring and Beverly Maclaren is replacing her.
- 9. **PUBLIC COMMENTS:** At this time members of the public were informed that they could address the Committee regarding any item within the subject matter of this committee's authority, provided that no action be taken on off agenda items unless authorized by law.

**Introductions / Announcements:** Randy Pawloski introduced Kevin Haskins, Assistant DA, who will be working with him on the OCCP.

**Legislation/ budget update:** The Governor has proposed a \$1 billion transfer now from county and state First 5 reserves then 50% of all revenue going forward. "Reserves" are not as they seem; many county have funded multi-year commitments. This proposal will impact existing programs and staffing. Orange County is advocating for local control of funds; these funds are one of the few allocations that provide equity for Orange County. This change will need a vote. Surveys show the voters continue to support funding early education and children.

Cal Optima: Health Families at risk; providers face a 10% cut; limitations on prescriptions. Cal Optima is trying to determine what to fund; currently watching and waiting.

Mike Ryan noted the decision that AB3632 does not cover the costs of room and board; the Department of Education will need to cover that cost.

**ACTION ITEM**: Review and approve minutes from the January 20, 2011 meeting. Minutes approved.

**16<sup>th</sup> Annual Report on the Conditions of Children:** Last call for reports – none requested.

The contract for the 17<sup>th</sup> report will start on April 22<sup>nd</sup>. The orientation for agency data staff is set for April 29<sup>th</sup> at 8:30 a.m. A notice will go out from CSUF. The data providers will receive a packet with their pages to review all past year's printed and affirm it is correct. Those pages and the certification will be due March 31<sup>st</sup>.

A table of Report topics for the Special Section and Discussion Topics was circulated. Lively discussion was held and the follow topics are put forth for consideration. In March, proposing members will advise regarding the data available for the topic. Decision on topics at the April OCCP meeting.

The Superintendent reviewed the proposed High School Promise and suggested that the focus should start with 8<sup>th</sup> Graders. Perhaps an 8<sup>th</sup> and 9<sup>th</sup> grade Promise. Consider the Governor's on line Pledge for youth fitness.

With Promise the OCCP could provide awards or incentives for the youth to keep their Promise. Discussion on the commitment of youth to a "promise." Maybe there is a better word.

Goals for 2011 distributed. Please review. At the March 2011 meeting, each agency should be ready to discuss how their agency will help support these goals.

Frances noted that the OCCP was developed to look at how all agencies can impact the shared goal of High School Completion for OC youth. Not just a job for OCDE. We should identify the linkages in the HS Promise to different agencies so all are influencing the outcomes.

Rick Martin 10 Educational Commandments can be trained and applied in all agencies.

Alyce encouraged the sharing of national models: Harlem Children's Zone, Promise Neighborhoods etc. How can we move forward as a community to mobilize these types of partnerships.

**Child Abuse Prevention Roundtable:** Russell Brammer reported that there is a new tool for pregnant and parenting moms: text Baby or BEBE to receive free tips a few times a week. Shawne Marsh noted that Cal Optima has a contract so all mother's in their programs will get this service.

Parents Anonymous National has launched a parent support line from 10 .a.m. to 7 p.m. Any parent can call to get support.

The Roundtable is forming up. Recent meeting discussed the budget at state and county and raised the question of how CBO's can be a voice in program design/ evaluation before an RFP or contract is issued. Mike asked members to discuss how their agency's have gathered community stakeholders prior to contract development.

Russell supported Dr. Handler's comments on a Center for Excellence. A similar comprehensive, residential resource was available in Dallas Texas. Russell will bring information to the March meeting.

### Annual Report on the Conditions of Children

- 1) Funding Subcommittee Report Mike Ryan reported the following:
  - > The Subcommittee met on May 11, 2011.
  - The County can accept donations from individuals and non-profits. If it's over \$10,000, we are required to go to the BOS for approval.
  - It is more complicated if we accept donations from commercial entities, but it can be done.
  - Soliciting funds is difficult for government agencies, however, CBOs and our stakeholders can solicit for government agencies.
  - Dana Stits is going to write a county counsel opinion on this item and have it ready for the June 2011 OCCP Retreat. The OCCP will then decide how to proceed.

# 2) FY12/13 RFP Recommendations – Mike Ryan reported the following:

- ➢ The cost of Annual Report contract has been \$108,400.
- Printing costs are currently budgeted at \$15,000. Last year the Contractor spent \$12,523 for 4000 copies of the report.
- One recommendation is to decrease the number of printed reports and have people access the report on-line.
- > Another recommendation is to possibly only print quick guides.
- It was recommended that several community forums be held throughout Orange County, instead of one forum at Cal State University Fullerton. This will encourage community participation, support, and buy in. There was a discussion regarding connecting with community leaders and the right people to ensure success.
- It was also recommended to coordinate the Annual Report with other community indicator reports. There was a discussion that the reports may not be compatible and it may be that the Annual Report needs to remain a separate report. This item will require further discussion/research. A meeting will be scheduled in the near future and any one interested is welcome to participate.

Mike Ryan reported that SSA Contracts is on a tight timeline to issue the new Annual Report RFP. If the OCCP is going to make significant changes to the Annual Report, it may be in our best interest to complete an RFP for only one year only. This will allow SSA award the contract by March 1, 2012 and have the 18<sup>th</sup> Annual Report available in November 2012. This will then allow the OCCP to determine what changes, if any, will be made to the Report/Forum for future years.

3) June 16<sup>th</sup> OCCP Retreat – Mike Ryan reported that a Planning Committee is being formed to develop the agenda for the OCCP Retreat that is being held at SSA Training and Career Development (TCD), 1928 S. Grand Ave., Santa Ana, June 11, 2011, 9am – noon.

The Planning Committee includes Mike Ryan, Alyce Mastrianni, and Mike Ruane. If anyone else is interested, please let Mike know.

Items that they anticipate putting on the agenda so far include:

- Fund raising activities
- Should OCCP pursue funds to support/develop programs or support agency efforts in pursuing grants (be an oversight committee of the program)?

- > Dana's County Counsel opinion regarding fund raising
- Future design of the Annual Report

**Educational Attainment** – Rick Martin provided the following handouts:

- Matrix of Services to Support High School Completion agencies provided updates on services they had in place last year and the Matrix was completed.
- OCCP High School Completion Task Force Committee outlines the OCCP Mission and indicators of high school completion. OCDE has identified the following as indicators of high school completion:
  - Reading at grade level by 3<sup>rd</sup> grade
  - Scoring at grade level in math in the 4<sup>th</sup> grade
  - Highly positive attendance rate
  - Involved parents
  - Zero F's on a report card
  - Little to zero drug use
  - Few school placements
  - Positive connection to an adult
- High School Dropouts: Selected Facts Orange County had a 10.9% drop out rate in 2008. This was the lowest in California. Drop out rates are disproportionate by race/ethnicity with the State percentage at 32.9% for African American/Black students. We need to ensure we are talking to/targeting the right communities.
- High School Graduation Pledge sample

Rick requested that the OCCP 1) identify how each agency can target the identified indicators and 2) provide the High School Completion Subcommittee with direction.

There was a discussion regarding high school completion and the direction of the OCCP and the following points/suggestions/ideas were made:

- The OCCP should look at successful programs to see what they did, what was done differently, etc. Are there models that can be duplicated (Promising Neighborhoods)? This can also include successful programs within Orange County schools.
- Promising Neighborhoods identifies additional indicators of success which the Subcommittee will add to the list.
- Each OCCP agency should look at what they are currently doing to impact the indicators (outlined on the Matrix) and then identify what they aren't doing, identify gaps and things they can do/how they can have an influence on the indicators. The Sheriff Department needs to be added to the Matrix.
- The High School Subcommittee could bring information/best practices to the OCCP on a quarterly basis and individual agencies could decide what they can do to have an impact. For example, OCDE is going to follow through with the High School Promise, another agency may want to hand out the Ten Commandments, etc. The Subcommittee could update the Matrix on an annual basis.
- We should look at how to leverage each others resources, weave our assets together, and refer to each others programs.

- Marketing is key to get the word out that high school completion is a priority for the OCCP. How do we put the responsibility on the community? Does the community know about the OCCP and what its function is? Do grassroot organizations know what's important to the OCCP? How can the OCCP support grassroot organizations?
- The role of the OCCP is not to do something as a group, however, as individual agencies we can all contribute and have an impact on the indicators.
- Should the OCCP select one or two indicators to really focus on/impact?
- Should the OCCP conduct a "road show" and have a couple of members present this to organizations, hand out the Ten Commandments, give organizations examples of how they can become involved, etc.?

These ideas will all be presented at the OCCP Retreat and it will be determined how the OCCP will proceed.

Mike asked participants - Does the OCCP want to do more? What does our mission look like moving forward? What do agency directors envision of the OCCP?

**OCCP goals** – Michael Ruane stated the OCCP needs an overarching goal that we are all moving toward. In moving forward with developing goals it is important to remember that our values are embedded in our goals.

Participants completed a SWOT (Strengths, Weaknesses, Opportunities, and Threats) Analysis exercise with the focus on Orange County and there was a discussion regarding everyone's results. Perlee Trout scribed on flipcharts and Michael Ruane facilitated the discussion. The SWOT analyses completed by each participant and the flipcharts will be transcribed and summarized by Commission staff.

Participants reviewed the *Think Together* – *Outcome Indicators* matrix (handout). There was a discussion if we should use this model as a framework for the OCCP and the high school completion focus/goal. If we proceed with this model, we also need to identify who else needs to be at the table.

Michael Ruane discussed the Triage model, which is a medical term but it is also used for strategic planning and goal setting –

- Things that no matter what we do, we will have no impact
- Things that no matter what we do, they will be okay
- Things that we can have an impact on

The group can use the SWOT analysis to identify priorities and key strategies. The OCCP needs to focus on the things we can accomplish through collaborative efforts and Michael Ruane explained the importance of being proactive rather than reactive. Partnerships with the non profit community are critical so we need to be sure they are aware of what we do and that we view them as community partners not contractors.

Michael Ruane identified three things the OCCP can do that are under our control -

- Media highlight the work we do and spend time getting a positive message out
- Integrating around high school completion
- Costing out the consequences of not doing it

Participants discussed next steps for the OCCP. It was decided that the *Think Together* model (handout) is a good tool and starting place for the OCCP.

While the consensus was the OCCP needs to move forward, there was uncertainty on what specifically we are moving forward on.

It was decided to hold another OCCP Retreat in place of the July 2011 meeting. Prior to the Retreat, all agencies should review the *Think Together* matrix and be prepared to discuss how they fit in. All agencies should be able to see themselves in this model. Michael Ruane stated that if we proceed with this model, it is very important that our final version is easily understood by everyone with no explanation required.

**Conditions of Children Report** – Mike Ryan stated the new RFP cycle will begin and SSA Contracts is finalizing the RFP. It will be a one year RFP with options for additional years. This will give the OCCP additional time to determine if significant changes will be made to the report. It will be determined during this next year, if the report can be merged with other existing reports. Also, in the future, if the report is only available online, we need to ensure that it's user friendly.

A suggestion was made that there should be a preface in the report that "children and youth are important and that is why this report is done."

One change the OCCP has agreed on for this RFP cycle is five community forums, one in each supervisorial district, versus one large forum. It was also decided that the RFP will include a requirement to print 1000 reports and 2500 quick guides.

**Annual Report on the Conditions of Children –** Michelle Berelowitz handed out the Annual Report Progress Report, dated June 15, 2011, showing what information has been received to date. Education data will be late again this year. Please remind agency contacts to submit any outstanding data and to update their 'What's Happening' sections as soon as possible.

Marty Ortegon handed out a list of all discussion topic workgroups with current participants and the dates the groups met. Any one is welcome to participate on a subcommittee if they are interested in a topic or if they know someone who should participate, please let Marty know as soon as possible. In addition, the workgroups will be the ones reviewing the drafts of the Special Section and Discussion topics. Anyone who would like to be part of the review process should tell Marty so they can be added to the distribution list. Otherwise they will see the final drafts in August 2011 and vote to approve/send to print in September 2011.

Michelle displayed four potential covers for the Annual Report and the committee selected one. Dr Handler suggested adding an OC landmark to the selected cover. The font inside the report will be orange and black.

**OCCP goals/THINK Together/HS Completion Subcommittee** - Since the last meeting Dana Stits completed an overview of the OCCP including historical information. The document was emailed prior to the meeting. Dana was acknowledged for the thorough summary.

There was a discussion regarding how the OCCP could accept donations. One suggestion was to use an agency such as the Raise Foundation to collect donations and the OCCP will instruct how to spend. There was a discussion on the focus of the OCCP - Does the OCCP want to identify best practices and fund them as start ups with grants/corporate donations? Does the OCCP want to actively partner with

community stakeholders? Is the OCCP strictly an advisory board? If the focus shifted, would it require BOS approval? There was a discussion regarding how the OCCP could make an impact. Could organizations apply for grants/funding with OCCP support/oversight?

The group reviewed the THINK Together model and the Matrix of Services document the High School Completion Subcommittee developed. There was a discussion regarding establishing a Center of Excellence in OC.

Once the OCCP has gathered common themes from individuals/groups addressing high school completion, identified what is working, identified where there are gaps, and identified what resources are needed, they will decide what to do to move forward to impact high school completion.

- High School Completion Subcommittee should add members SSA, Public Defender, and Probation. Agencies should send the names of the representatives to Tricia who will forward to Rick Martin.
- High School Completion Subcommittee will put their information into a format similar to the THINK Together Outcome/Indicators model for the August 2011 meeting.
- High School Completion Subcommittee will have a sample survey for the OCCP to review at the September 2011 meeting.
- Alyce Mastrianni will ask THINK Together to present at the August 2011 meeting.
- OCCP meeting time will change to 8:30 a.m. 10:30 a.m. beginning with the August 2011 meeting.
